We are looking for a mid to senior healthcare leader to provide program management and oversight of successful program delivery. The successful candidate would have a passion for advancing patient care and digital health who is skilled at complex stakeholder engagement and brings significant experience in overseeing successful delivery of largescale healthcare programs.

### General responsibilities

- Lead the strategic design and execution of this new provincial digital integration and implementation initiative (led by a consortium of partner organizations including CEP)
- Oversee all initiative efforts including, but not limited to:

- Develop efficient and suitable strategies to achieve program deliverables
- Maintain oversight of agreements between program and consortium partners
- Achieve deliverables, budget and timeline management, reporting, evaluation and risk mitigation.
- o Governance management
- Collaborate and build consensus with external stakeholders to support the development of the strategy
- Establish and maintain strong internal and external relationships with clients, partners, key stakeholders, clinical leads and experts.
- Work with provincial and regional leaders to provide recommendations and consultation on policy and issues affecting access to service delivery
- o Prepare and maintain program documentation in preparation for audits
- Support organization level efforts as a member of the senior management team related to human resources, finance and business development.
- Lead and support a team (including project managers, coordinators, analysts and other roles).
- Perform other duties as required
- Reporting to the program consortium executive committee.

- Experience managing the implementation of large-scale provincial programs
